





Priority Area Scores










ACHIEVEMENT






English Language Arts Score: 72.0 Mathematics Score: 94.2




GROWTH

This priority area measures year-to-year student progress on statewide tests. It uses a value-added model that seeks to control for circumstances beyond the influence of educators. 




TARGET GROUP OUTCOMES


